

The MM2H visa permit is initially for a period of ten (10) years (depending on the validity of the applicants' passport) and is renewable.

It is open to citizens of all countries recognised by Malaysia regardless of race, religion, gender or age. Applicants are allowed to bring their spouses and unmarried children below the age of 21 and parents as dependents.

The MM2H visa permit is now attracting foreign citizens to Malaysia not only to stay but also to use it as a base from which:

- to conduct business overseas
- to educate their children
- to retire or semi-retire

MM2H visa permit- Benefits & Incentives

Once your application is successful, there are various benefits & incentives provided as below:

MM2H Visa Permit

- 10 year Social Visit Pass with Multiple Entry will be granted
- Stay as long as you wish & leave Malaysia anytime as you please
- Renewable after 10 years

House Purchase

Each participant is allowed to purchase residential houses valued above RM500,000 / RM1,000,000 depending on the state. Theremay be changes with individual states. NOTE: Property purchase is NOT required for the MM2H visa.

Domestic Helper

Each applicant can apply for one maid subject to the prevailing guidelines of the Immigration Department.

Education

MM2H participants are allowed to bring their children who are below 21 years old and not married as their dependants.

Tax

Tax Exemption is given to remittance of offshore pension funds into Malaysia & any other foreign funds transferred into Malaysia.

Business & Investment

You can own your own business, terms apply. Generally any MM2H visa holders can own their own business as Directors without the requirement of any Local Malaysians, terms may apply.

Working Part Time

Over 50 year olds can work part time, terms apply.

Other

- Import personal / household items, tax exempted
- Invest in local companies, share market & unit trusts
- Interest gained from bank fixed deposit is tax exempted
- Your parents can also join you as dependents under a renewable long term (6 monthly) visa



MM2H Visa Permit - Requirements

Pre-Apporval Stage

Applicants are required to comply with the following financial criteria upon successful submission of their MM2H application.

AGE	LIQUID ASSETS	MONTHLY INCOME	HOUSE OPTION	FIXED DEPOSIT
50+	RM350,000	RM10,000	NIL	RM150,000
50-	RM500,000	RM10,000	NIL	RM300,000

Post-Apporval Stage

Successful applicants are required to comply with the following financial Fixed Deposit placements upon receipt of the "MM2H conditional approval letter" from Malaysian Immigration Department.

Aged Below 50 years old

- Open a fixed deposit account of RM300,000.
- After a period of one year, the participant can withdraw up to RM150,000 for approved expenses relating to house purchase, education for children, medical bills & car purchase in Malaysia.
- Must maintain a minimum balance of RM150,000 from second year onwards and throughout stay in Malaysia.

Aged 50 years and Above

- Open a fixed deposit account of RM150,000.
- After a period of one year, participant who fulfils the fixed deposit criteria can withdraw up to RM50,000 for approved expenses relating to house purchase, education for children, medical bills & car purchase only in Malaysia.
- Fixed deposit participant must maintain a minimum balance of RM100,000 from the second year onwards and throughout his/her stay.

Notes

- Nuccessful applicants need to open their fixed deposits in Ringgit Malaysia (RM) only.
- Naticipants need to obtain approval from Ministry of Tourism before proceeding to withdraw the fixed deposit.
- Participants under this program may withdraw their entire fixed deposit anytime should they decide to terminate their stay in Malaysia under this program. However, they must obtain prior approval from the Ministry of Tourism.

Other Post-approval Stage Requirements

Medical Report

All applicants and their dependents (spouse and children) are required to submit a medical report from any private hospital / registered clinic in Malaysia.

Medical Insurance

Approved participants and dependents (spouse and children) must possess a valid medical insurance policy, which is applicable in Malaysia. If any applicants are above 60 years old then this requirement is waived.

Restrictions

Participants under Malaysia My Second Home Programme are not allowed to work/be employed while staying in Malaysia. In addition, they should not participate in activities that can be considered as sensitive to the local people and a threat to the security of the country. However you can get permission to work part time if above 50 years old.

MM2H Visa Permit - How To Apply

Step 1. Submit an Online Enquiry or Email us

Receive our official MM2H Information Pack including details of our Company & Services.

Step 2. Submit your documents for application

Documents required:

- Letter of Application from main applicant
- Resume/ CV of main applicant
- 1 Set of MM2H Application Forms for each person
- 4 Coloured Passport Size Photographs for each person
- Copy of Passport Main Page and Malaysian visa page for each person
- Certified True copy of Marriage Certificate (for Applicants with spouse)
- Certified True copy of Birth Certificates (for children only)
- Certified True copy of latest 3 months bank statements or other financial documents showing liquid funds
- Certified True copy of latest 3 months bank statements showing income as deposits into a personal bank account
- Certified True copy of latest 3 months copies of pay slip, pension slip or income statement
- Criminal Clearance Letter/Certificate from government agency Police report from country of residence or citizenship (for main applicant only)

All copies must be certified TRUE COPIES OF ORIGINAL DOCUMENTS by EMBASSY / HIGH COMMISSION/ NOTARY



documentation is complete)


Step 3. Approval letter issued by Immigration

SCHEME A - FULL MM2H; Documentation, Submission & Post Approval Services

- Provide latest and comprehensive information regarding the terms and
- conditions to applicants who are ready to join the MM2H Program.

- Advice clients to come to Malaysia within 6 months from the date of approval of the Conditional Approval letter to fulfil all the required terms and conditions.

- An Invoice will be generated upon a successful MM2H Submission to the MM2H Immigration Centre. An official Government Receipt will be issued.
- All payments are due within 7 days of receipt of Invoice sent to the applicant either via Email/ Fax/ Post/ In-person.
- Our Fees structure is subject to change at anytime without prior notice.

Other Fees payable by applicant:

- All Visa Fees including MM2H Visa (RM90/yr per person).
- ► MEV & JP Visa Fees (approx +/- RM20/RM520, only for persons normally requiring visa to enter Malaysia).
- All Authority fees payable by cash only.
- In the event of the applicant or any of the dependents losing their right on the MM2H visa, after being endorsed, because of being in breach of its terms & conditions, the personal bond which we have committed to will be payable by the applicant on demand from the government.

Appeal & Refund Policy:

- Appeals against rejections will be done free of charge in terms with the Ministry's requirements.
- Refund will be given back in FULL after final rejection.
- If rejection is due to the applicants' negligence, failure to provide correct, accurate or insufficient documents for application no refund will be given.
- If based on bank & income verification failure then too no refund will be given.
- No refunds will be entertained if the applicant has not fulfilled the Ministry's terms, conditions requirements and procedures of the MM2H program.
- No refunds accepted if rejection based on Government Sanctions/regulations and/or Security failure etc towards an individual applicant or country.
